

The BBNCEF accepts applications for the Short-term Vocational Education (STVE) program throughout the year, pending available funds. To be eligible for this scholarship funding, you must be a BBNC shareholder enrolled in a short-term training program that enhances your opportunities for employment or promotion.

Effective January 1, 2016! – The maximum scholarship award under an STVE program is up to \$1000 per person, per calendar year. Awards must be used within three months of the award date.

STVE scholarship awards may not be used for courses that have already begun or completed prior to the application being received and approved for award of a specific program. Awards must be used for the training period awarded and may not be carried forward.

STVE recipients who do not honor STVE award conditions during the awarded training period may be subject to a probationary period of one year from the date of the violation where the student will not be eligible to receive STVE funding. After the probationary period ends, the student will be eligible to again apply for STVE funding. Questions? Please contact the BBNC Education Foundation at 907-265-7856.

NOTE: The budget for this program is limited. Applications are reviewed on a first come – first served basis and must be complete before an award will be considered.

The application and eligibility requirements are:

1. Applicant must be a BBNC Shareholder.
2. Submit a complete scholarship application.
3. Provide verification of enrollment from the school/training provider and include a description of the training.
4. Submit a **letter of request** that answers these questions:
 - What are your employment goals?
 - How does this training relate to your employment goals?
 - What are your employment opportunities after training is completed?

You may send in your application by mail, email or fax. Please make sure to submit the application and all attachments, including your letter of request and proof of enrollment or registration from your training provider or institution.
